Short-term disability insurance pays the insured a part of his or her income for a specific (short) period after he or she uses time-off bank days. Depending on the individual plan, short-term disability typically pays benefits from nine weeks to 52 weeks, or a full year. Most short-term disability insurance plans pay the insured about 50 percent of his or her weekly wage as a benefit.

Short-term vs. Social Security Disability: Some people who go on short-term disability are able to return to work within a matter of weeks or months. For others, short-term disability is only the first step in a transition from active employment to long-term or permanent disability. In either instance though, short-term disability insurance only typically pays for a somewhere between 6 and 52 weeks, with the average plan providing between 9 and 12 weeks of coverage.

Disability benefits are available only to people with impairments so severe that they prevent any kind of significant, profitable work. Social Security pays only for total disability. No benefits are payable for partial disability or for short-term disability.
